2. Title of the Practice:Reaching out: Consolidating Ties with the Community

Objective of the Practice: To stay connected and form solidarity among community

The Context:NSS unit of our college helps to cultivate a sense of social responsibility in the students and inspire community work. This entails taking teaching beyond books and text and bringing it closer to contact.

The Practice: Our College is associated with Bharat Swabhiman Nyas (Yoga Patanjali) Along with our students the women of nearby areas join during the morning Yoga practice. During COVID Pandemic, the NSS unit of our college reached out to the inhabitants and aware them about the precautionary measures for COVID. They distributed hand stitched masks (for which they contributed money and stitched masks) and food grains to the deprived inhabitants of Pandeydih, Shitalpur and Bhandaridih.

Evidence of Success: The participation of women in Yoga practice and involvement of girls in stitching masks, spreading awareness, distributing food grains are all evidence of success.

Problems Encountered and Resource Required: During covid time bringing girls together was risky even following all protocols.

3. Title of the Practice:Promoting Eco-friendly and Sustainable Environment

Objective of the Practice: To bring among our students the concern for ecological balance

The Context: We inculcate sensitivity and responsibility towards environment in our students.

The Practice: To make the campus eco-friendly, the college maintains ornamental gardens, plants saplings and conserves water through water harvesting and also installed Solar Light at the gate.

Evidence of Success: Above mentioned things can be counted as evidence of success.

Problems Encountered and Resource Required: During COVID time when college was closed unwanted wild grasses and bushes were grown. One gardener is required to maintain the garden.
